**Board Meeting Call to Order:** D. Pearson called the Board Meeting to order at 5:31 pm

#### New Business

**Peace Vigil:** D. Pearson welcomed Shaamini Babu, Esq. to the meeting and asked her to review the information about the Peace Vigil. Ms. Babu explained that she was working to coordinate a Peace Vigil with local bay area Bar Associations to provide a place and time that members of the community can gather to advocate for children safety, especially in light of the Israel/Palestinian conflict. She expressed the idea that “the message to protect children is louder and more impactful when there are more advocates.” Discussion was held regarding this idea and it was offered that, if this were to happen, that the message go beyond the current conflict in Israel and Palestine, and to include all of the other areas in the world in which conflict is happening and children are unsafe. Ms. Babu did not make a direct ask of the Board of Directors at this time.

**In Person Board Meetings** – D. Pearson explained to the Board that some Board members are frustrated at the lack of attendance to in-person meetings. Some work diligently to be in person and when few show up, feel there is futility in the effort. Further, one Board member expressed frustration that this meeting was moved last-minute to Zoom only after making significant scheduling decisions to ensure they could attend in person. Further, it was noted that, as per the bylaws, we are to be meeting at the CCCBA Offices and that is what we advise the community so that, if they would like to, they can also attend. No formal motion was made, but by consensus the Board did agree to be more intentional about responding to J. Iorns with their attendance intention (by zoom or in-person).

**Calls for Self-Nominations** – J. Iorns advised the Board that the nomination process for new Board Members is open and folks are encouraged to reach out to interested members to apply. A question was raised about which Board Members’ terms are coming to an end this year. J. Iorns looked at the records and identified that D. Christopherson and J. Lee 1<sup>st</sup> terms are ending this year.

#### Old Business

**CCJFA Bylaws & related paperwork:** D. Pearson referred to the paperwork that was included in the Board packet as requested at the last meeting.

**Laura Ramsey Memorial Activities:** E. McKenna gave brief update and advised is working with S. Selleck on drafting the language for use in CCCBA outreach and support efforts. Further, Laura’s old firm is holding a memorial service for Laura on Saturday, May 18, 2024

**State Bar Dues Increase** – J. Iorns reported an update that the State Bar Dues Increase townhall is set for June 13, 2024.

The event was well attended, and the Membership/Social committee is looking to do something similar for the Minority Bar Coalition.
